The Government is in view of dispensing the present system of material testing in the premises of Manufacturers by Q.C Wing of RWS Department and to entrust the testing of materials to third party agencies so as to improve the quality of works being executed in RWS department by diverting the main focus of Q.C.Wing on execution of works.

2. In view of the circumstances stated by the Chief Engineer, RWS & S, A.P., Vijayawada in the reference cited and in order to not to stall the process of works and achieving FHTC targets, Government, after careful examination of the matter, hereby decided to continue with the present system temporarily with the following modifications superseding all the orders given earlier for both SVS and MVS works with sole responsibility of quality of all materials being used in the Department with the field engineers until finalization of third party agency.

**I. For material testing:**

S.No	Work costing	Inspection Officers
1.	Rs.5.00 crores and above	SE, RWS&S concerned and EE/Dy.EE., RWS&S concerned. The S.E concerned will issue the test certificates
2.	Work costing less than Rs.5.00 crores upto Rs.1.00 crore	Executive Engineer, RWS&S concerned along with field DEE/AEE/AE RWS&S. The EE(RWS) concerned will issue the test certificate.
3.	Work costing less than Rs.1.00 crores	Dy.E.E(RWS&S) concerned along with field AEE/AE RWS&S. The Dy.EE(RWS) concerned will issue the test certificate

**II. Quality Control Inspection Certificate:**

S.No	Description	Intermediate Q.C.	Final Q.C
1.	For works costing upto Rs.1.00 crore	Concerned Dy.E.E, V&QC, RWS&S, Sub Division will issue the certificate	Concerned Dy.E.E., V&QC, RWS&S sub Division will issue the certificate.
2.	For works costing more than Rs.1.00 crore	Concerned Dy.E.E, V&QC, RWS&S, Sub Division will issue the certificate	Chief Engineer, V&QC will issue the certificate.
