**ORDER:**

In the G.O 1<sup>st</sup> read above, the Government have issued various measures for improving the quality of works relating to all Engineering Departments in I & CAD Department, based on the recommendations of the Advisor to Government (Quality Control) of Andhra Pradesh. Among which, the Check Measurement requirements for various cadres were issued in para-2 (viii) of the said G.O.

2. In the letter 2<sup>nd</sup> read above, the Engineer-in-Chief (AW/IW) & Chairman, BoCEs, WRD, while furnishing the proposals for 'Amendment to Check Measurement Requirement by various cadres in all Engineering Departments' has stated that the matter was placed before the 8<sup>th</sup> BoCEs meeting held on 09.12.2019 and the BoCEs members have made recommendations to the Government to amend the earlier instructions issued in clause (viii) of para-2 of the G.O. 1<sup>st</sup> read above. Accordingly, the ENC (AW/IW) & Chairman, BoCEs, WRD, has communicated the Minutes dt. 09.12.2019 and requested the Government to issue necessary orders for amending the "Check Measurement Requirement for various cadres".

3. Government after careful examination and as recommended by the BoCEs, hereby issue the following amendment to the earlier instructions issued in clause (viii) para-2 of the G.O.1<sup>st</sup> read above:
