In the G.O. 1st read above, orders were issued bifurcating the Panchayat Raj Engineering Services in to Panchayati Raj Engineering Services and Rural Water Supply Engineering Services and a new Engineering Department of Rural Water Supply and Sanitation Department was formed.

In the G.O. 3rd read above, orders were issued that the Rural Water Supply and Sanitation Department shall be deemed to have been created with effect from 01.04.2008.

In the memo 4th read above, the Engineer-in-Chief, PR, A.P., Vijayawada has communicated the Provisional Seniority List of Assistant Executive Engineers appointed and promoted in PRED between the Years 1990-95.

In the Memo 5th read above, Provisional Seniority List of Assistant Executive Engineers who have opted and working in RWS&S is prepared and communicated duly inviting the objections, if any, from the individuals.

Certain objections were received in certain zones determining the date of regularization of UK-1990 batch as 15.12.2001 instead of the date of regularization as mentioned in their Service Register. On due verification of the objections raised by the individuals, the individuals were placed at the appropriate place in their respective zones taking their date of regularization into consideration in the cadre of Assistant Executive Engineer and also based on the promotion to the cadre of Deputy Executive Engineer on adhoc basis issued in RWS&S Department earlier.

In response to the said seniority lists, the following individuals have submitted their objections:

1. Sri Erigela Srinivasa Reddy, Deputy Executive Engineer, RWS&S Sub-Division, Mantralayam @ Yemmiganur. Relevant documents submitted for clearing objection.

Gist of Objection:

He has submitted that, his surname was wrongly mentioned as "Elisetty" instead of "Erigela".

Remarks:

His surname is corrected as "Erigela".

2. Elisetty Sreenivasulu, Deputy Executive Engineer, RWS&S Sub-Division, Puthalapattu, Chittoor.

Gist of Objection:

He has submitted that, his qualification is M.Tech., (Civil) but written as B.Tech., (Civil) and relevant documents submitted for clearing objection.

Remarks:

His qualification is corrected as M.Tech., (Civil)

3. Saladi Vidya Sagar, Deputy Executive Engineer, RWS&S Sub-Division, G.D.Nellore

Gist of Objection:

He has submitted that, his surname is Saladi but it is mentioned as Salai and the 2nd objection is his qualification is mentioned as B.Tech., (Civil) instead of M.E. (Civil).

Remarks:

His surname is corrected as Saladi and his qualification is corrected as M.E. (Civil).

4. Certain objections received from the employees recruited after bifurcation of the Department i.e., during the years 2010, 2011 and 2013 recruited through APPSC.

Gist of the Objection

The employees have questioned the placement of employees recruited during the years 1990-95 Temporary in the erstwhile PRED stating that, they should be placed after direct recruitees of APPSC batches.

Remarks:

The services of the temporary employees who were recruited during the years 1990-95 were regularized by the Engineer-in-Chief, PR, before the date of bifurcation of RWS&S Department from PRED.

The objections were invited from the individuals who were covered in the annexure to the memo but the objections were received from the individuals who are not covered in the annexed to the memo. Hence, the objections cannot be maintainable.

Therefore, the provisional seniority list of Assistant Executive Engineers of PSC - 1997 Batch and Temporary 1990-95 batches are hereby confirmed.

The confirmed seniority list now communicated is subject to final outcome of the batch cases filed in W.P. No. 24543, 24549, 24572 of 2021 filed by certain Assistant Executive Engineers on implementation of G.O. Ms. No. 71, Dt. 05.10.2021 and other O.A.s/W.P.s/SL.PS., if any, pending in the Hon'ble Courts.
