This is to bring your notice that RWS&S Department Engineers are executing top most priority and flagship programs of the Government like Jal Jeevan Mission (Aug/Retrofitting/Saturation -60,062 works with Est.Cost-12831.35 Cr, Jagananna Housing Colonies –Hon'ble CM Sir's Manasaputrika with 15,459 works-3266.19 Cr, 9 Water Grid Projects with Rs.10137 Cr, NADU NEDU GGMP, CSCs, NREGS Drains, NABARD, ZP General Funds, MPP Funds, O&M of CPWS Schemes, SWSM Sheds and Gram Panchayath 15 FFC Grant Works and other District Level works sanctioned by District Collector without any supporting staff available to section officers at field.

Further, execution of Magic Soak Pits in Jagananna colonies by RWS Engineers vide Memo No.2117977/R.D.II/A1/2023 dated.21.06.2023 is very difficult with this heavy work load and RWS&S Engineers have no sub staff, computer operators at field level to prepare estimates for each and every soak pit, beneficiary wise online and it is to inform that Housing department is already coordinating with beneficiaries for construction of houses and they may be entrusted to Housing Department for better liasioning and coordination with beneficiaries or as per earlier process of executing with MGNREGS staff having sub staff Mate, Field Assistant, Technical Assistant , Engineering Assistant as they have already executed Soak pits under MGNREGS.

In view of the above we request the authority to exempt the execution of Magic soak pits by RWS Engineers otherwise we are unable to executed present works taken up under JJM/ JHC and we will discuss this matter with all the members and call for further plan of action.
